DIRECTIONS TO CRC 2009 HOTEL

From Points North

Take I-95 South
Merge onto I-495 W/CAPITAL BELTWAY via EXIT 27 toward SILVER SPRING. (4.6 mi)
Merge onto US-29 S/COLESVILLE RD via EXIT 30 toward SILVER SPRING. (1.8 mi)
Turn LEFT onto GEORGIA AVE NW/US-29. Continue to follow US-29 (Crossing into DISTRICT OF COLUMBIA). (5.8 mi)
US-29 becomes 7TH ST NW. (0.9 mi)
Turn RIGHT onto H ST NW. (0.3 mi)
Turn LEFT onto 11TH ST NW. (0.1 mi)
Turn RIGHT onto G ST NW. (0.1 mi)
Turn RIGHT onto 12TH ST NW. (0.1 mi)
End at 775 12th St NW Washington, DC 20005

From Points Northwest

Take I-76 East to I-70 East to I-270 South
I-270 S becomes I-495 E/ CAPITAL BELTWAY. (3.8 mi)
Take the MD-97 S/ GEORGIA AVE exit, EXIT 31B, toward SILVER SPRING. (0.2 mi)
Turn SLIGHT RIGHT onto MD-97 S/ GEORGIA AVE. Continue to follow MD-97 S. (1.4 mi)
MD-97 S becomes US-29 (Crossing into DISTRICT OF COLUMBIA).(5.8 mi)
US-29 becomes 7TH ST NW. (0.9 mi)
Refer to directions from points north for continuation.

From Points South

Take I-95 North
Keep RIGHT via EXIT 170A-B toward WASHINGTON/I-495/TYSONS CORNER. (0.7 mi)
Merge onto I-395 N via EXIT 170A toward WASHINGTON (Crossing into DISTRICT OF COLUMBIA).(10.6 mi)
Take US-1 N toward DOWNTOWN.(1.1 mi)
Stay STRAIGHT to go onto 14TH ST NW (0.4 mi)
Turn RIGHT onto G ST NW. (0.2 mi)
Turn LEFT onto 12TH ST NW. (0.1 mi)
End at 775 12th St NW Washington, DC 20005

From Points Southwest

Take I-81 North to I-66 East towards Washington (Crossing into DISTRICT OF COLUMBIA).
Keep RIGHT at the fork to go on US-50 E. (1.4 mi)
Turn LEFT onto 12TH ST NW. (0.5 mi)
End at 775 12th St NW Washington, DC 20005
